

# Number Of Animals Permitted

## **Sec. 10.01.239 (Mission Viejo) : Numbers of animals permitted**

Every person owning or having custody of five or more licensed dogs or five or more cats, over the age of four months, for the purpose as described in section 10.01.400 must obtain the necessary additional animal license required under section 10.01.390.

## **Sec. 10-1-76. (Laguna Niguel) : Animal permit**

(a) Every person owning or having custody of four or more licensed dogs or four or more cats, over the age of four months, for any purpose other than a commercial purpose shall procure an animal permit from the director. The director shall issue a permit for the keeping of such animals upon receipt of the fee established by the city council and when, in his opinion, such animals may be kept or maintained without endangering the safety and comfort of such animals and the inhabitants of the neighborhood, and the owner or custodian has complied with any other applicable laws, including zoning regulations. Each such animal shall be individually licensed. The permit shall specify the number and types of animals authorized to be kept thereunder and may contain any conditions regarding the keeping of animals thereunder deemed necessary by the director. Animal permits shall be nontransferable and must be renewed annually. The city council may, by resolution, adopt regulations governing the keeping of animals under permit, including facility construction and maintenance standards. Failure to comply with such regulations or any conditions imposed by the director shall constitute cause for denial or revocation of such permit.

(b) The provisions of section 5-2-19 shall govern appeals from the denial or revocation of a permit under this section.

## **Sec. 6.04.170 (Aliso Viejo) : Animal permit required**

Every person owning or having custody of four or more licensed dogs or four or more licensed cats, over the age of four months, for any purpose other than a commercial purpose shall procure an additional animal license pursuant to Article X of this chapter. [Ord. 2012-145 § 8; Ord. 2010-126 § 1 (Exh. A); Ord. 2009-108 § 1 (4-1-29)].

## **Sec. 13-12.070 (Laguna Hills) : Number of dogs permitted**

Every person owning or having custody of five or more dogs, over the age of four months, for the purpose as described in Section 13-44.010, must obtain an additional animal license as required under Section 13-40.100. (Ord. 2017-1 § 1 (part); Ord. 2016-9 § 1 (part))

## **Sec. 5.12.360 ( Rancho Santa Margarita) : Number of dogs permitted**

Every person owning or having custody of five or more dogs, over the age of four months, for the purpose as described in Section 5.12.1100, must obtain an additional animal license as required under Article XI of this Chapter.
